1. Who We Are

- Legal authorities if required by law, We do **not** sell or rent your personal data to third parties.

7. International Data Transfers

Some of our third-party service providers may store or process your personal data outside the UK. Where such transfers occur, we ensure that appropriate safeguards are in place, including:

- Transfers to countries with adequate data protection laws
- Standard Contractual Clauses (SCCs) approved by the UK Information Commissioner's Office (ICO)
